1. INTRODUÇÃO

A qualidade da água fornecida aos seus consumidores é uma preocupação constante do Município de Celorico da Beira. Com o objetivo de assegurar o controlo da água distribuída aos seus Clientes são realizadas análises com o intuito de verificar o cumprimento dos requisitos de qualidade estabelecidos no Decreto-Lei n.º 152/2017 de 7 de Dezembro.

Esta legislação tem como premissa avaliar a qualidade da água na torneira do consumidor. Neste sentido foi elaborado um Plano de Controlo da Qualidade da Água, PCQA, para o ano de 2018, que mereceu a aprovação por parte da entidade competente – Entidade Reguladora dos Serviços de Águas e Resíduos - ERSAR.

O D. L. n.º 152/2017 no seu artigo n.º 17 refere que é obrigação da Entidade Gestora a publicação trimestral, dos resultados obtidos nas análises de demonstração de conformidade, acompanhados de elementos informativos que permitam avaliar do grau de cumprimento das normas de qualidade constante no anexo I, do referido D.L.

No presente documento, por cada zona de abastecimento e por cada parâmetro, são apresentados: O valor paramétrico; o valor mínimo e máximos obtidos; número de análises superiores ao V.P.; percentagem de análises que cumprem a legislação; número de análises agendadas e realizadas e a respetiva percentagem de análises realizadas.

Os documentos apresentados poderão ser usados para o referido fim, publicação trimestral.

É, também, enviada informação adicional, compilada, para a totalidade das zonas de abastecimento, apresentada em seguida.

3. INCUMPRIMENTOS

Apresenta-se, em seguida, o “Mapa de Incumprimentos”, onde são indicados (caso existam) os resultados que violaram o respetivo Valor Paramétrico definido no D.L. n.º 152/2017.

Nesta avaliação quando na coluna “Violação” aparece a indicação V.A., significa que foi registada uma violação ao Valor Paramétrico fixado no D. L. n.º152/17. Quando na coluna “Violação” aparece a indicação V.R. significa que os valores definidos, para os parâmetros Desinfetante Residual, N.º de Colónias a 22 e a 36 °C, Dureza Total, Cálcio e Magnésio, indicados como desejáveis no D. L. n.º 152/17, foram ultrapassados.

Os Níveis de verificação impostos para os parâmetros Alfa total e Beta total quando ultrapassados são, de igual modo, apresentados na coluna “Violação” com a indicação V.R..

Será enviado por correio eletrónico, um ficheiro IDQA, retirado do portal do ERSAR, onde poderão ser visualizados todos os incumprimentos registados.

No referido ficheiro, também, estão apresentados os locais de amostragem onde foi possível realizar as colheitas e os locais previstos inicialmente no PCQA.

A legislação no artigo n.º15 refere que as Entidades Gestoras devem avaliar se o local onde a amostra foi recolhida é de igual modo representativo da área da zona de amostragem que se pretende controlar. Se tal não for o caso a Entidade Gestora deverá proceder à alteração do ponto de amostragem no Portal da ERSAR.

4. COMENTÁRIO TÉCNICO DOS RESULTADOS

Neste trimestre foram registados três incumprimentos.

As zonas de abastecimento de Aldeia da Serra e Prados apresentaram valores de pH inferiores ao valor mínimo referido na legislação

Valores reduzidos de pH são característicos da água distribuída nas zonas de abastecimento em questão.

As zonas de abastecimento não possuem correção, de acordo com a informação retirada do PCQA apresentado à ERSAR. Assim, caso a autoridade de saúde não tenha identificado perigo para a saúde pública (ausência de parecer), os incumprimentos poderão ser encerrados no portal da ERSAR.

A zona de abastecimento de Salgueirais apresentou problemas relativos à sua qualidade microbiológica. Na amostra em questão foi registada a presença de agente desinfetante.

Situações deste tipo ocorrem com frequência quando: a amostra recolhida possui influência de água de uma origem particular; o local de colheita possui um depósito incluído na rede predial; o sistema de desinfecção é intermitente (levando a que o tempo de contacto não seja suficiente para promover uma correta desinfecção); ou existe alguma pequena ruptura na rede de distribuição.

Os Níveis de Verificação, estabelecidos para os parâmetros radiológicos Alfa-Total e Beta-Total, foram respeitados.

Resta referir que todas as 25 determinações efetuadas ao cloro residual livre apresentaram valores próximos da gama referida na legislação 0,2_0,6 mg Cl₂/L.

O CESAB coloca-se à disposição para a colaboração que entenderem necessária.
